

# Terms of Use

## Article 1 – Introduction

These Terms of Use ( “ Terms ” ) set forth the conditions for using the foreign currency exchange (forex) and cryptocurrency trading services ( “ Services ” ) provided by Karibu Co., Ltd. ( “ the Company ” ).

By using the Services, users are deemed to have agreed to these Terms.

## Article 2 – Description of Services

The Company provides the following services in accordance with applicable laws and regulations:

1. Foreign currency exchange (forex) services
2. Cryptocurrency trading services
3. Related and ancillary services

## Article 3 – Risk Disclosure

### (1) Risks Related to Foreign Exchange and Currency Exchange

- Exchange rates fluctuate depending on market conditions, which may affect the final amount received.
- Terms and policies set by affiliated exchange offices may change without prior notice.

### (2) Risks Related to Cryptocurrency Trading

- Cryptocurrency prices may fluctuate significantly, and no principal guarantee exists.
- Exchange or network issues may cause delays, failed transactions, or other disruptions.
- The Company shall not be liable for loss caused by wallet mismanagement or loss of private keys (except in cases of willful misconduct or gross negligence).

### (3) Other Risks

- Natural disasters, system failures, or other unforeseeable events may result in service delays or interruptions.

## Article 4 – Prohibited Conduct

Users shall not engage in the following acts when using the Services:

- Acts that violate laws or public order and morals
- Providing false information
- Acts that interfere with the operation of the Services
- Money laundering, terrorist financing, or other illegal acts

- Fraud, unauthorized access, market manipulation, or other prohibited activities

## Article 5 – Suspension or Termination of Services

The Company reserves the right to suspend or terminate the Services if the user violates these Terms or engages in prohibited conduct.
